THIS NOTICE DESCRIBES HOW INFORMATION ABOUT YOU MAY BE USED AND
DISCLOSED.

PLEASE REVIEW IT CAREFULLY.

- C22C Inc. is a voluntary organization which shares information provided by members, with other registered members, for the purpose of supportive networking. Members of C22C include families and interested professionals.
- Only members who select to be added to our network database or be published in our newsletter will have their confidential information shared between registered members.
